You have the right to transfer this benefit to another broadband provider qualified to provide the ACP. If you qualify and elect to participate in the ACP through Cellular One, we will subtract the benefit amount from the total cost of your plan. All qualifying plans must contain a data component. Qualifying participants on tribal lands will receive an ACP benefit of \$75 per month; qualifying participants on non-tribal lands will receive \$30 per month. If you do not use the total benefit awarded you will not receive cash back or credit for other services or products. If you choose to continue to receive the same service after this program ends, you will be subject to our undiscounted rates for purchased bundles and our general terms and conditions. Your account will revert to the same plan you had before opting into the ACP.
